

NON-COMMERCIAL DATA AND CODE LICENSE AGREEMENT

This Non-Commercial Data and Code License Agreement (the “Agreement”) is made between **Nanjing Geneseeq Technology, Inc.** (“GENESEEQ”) having an office at 128 Huakang Rd, Nanjing, Jiangsu, China 210032, and the user of the data and any associated code (“LICENSEE”) in the published paper “Multi-cancer early detection utilizing multidimensional cell-free DNA fragmentomics: development, validation, and prospective clinical investigation” in Natural Medicine (the “Paper”).

This Agreement is effective on the date the data in the Paper and any associated code (the “Data and Code”) is downloaded by LICENSEE (the “Effective Date”), and downloading the Data and Code constitutes acceptance of these conditions.

RECITALS

The Data and Code were developed under the direction of Dr. Yang Shao. Methods, algorithms, and analyses implemented in the Data and Code are described in the Paper (the “Inventions”), which are owned by GENESEEQ and may involve collaborations with other institutions.

LICENSEE desires to use the Data and Code to: (a) replicate the results published in the Paper, pursuant to the journal’s policy on code and data sharing; or (b) for non-commercial*, academic research (the “Purpose”).

* The term "non-commercial" strictly prohibits any use of the Data and Code that could lead to financial gain, profit, or commercial advantage, whether directly or indirectly.

GENESEEQ makes the Data and Code available to the LICENSEE on the terms and conditions set forth below.

AGREEMENT

1. Eligibility

- LICENSEE represents that they are either:
 - (a) an employee or student of a nonprofit research institution; or
 - (b) will use the Data and Code and rights granted herein solely to replicate the results published in the Paper.

2. Permitted Use

- LICENSEE will use the Data and Code only for the Purpose and in compliance with all applicable statutes and regulations, including export laws.
- LICENSEE agrees to cite the Paper in any publication or presentation of results using the Data and Code.

3. License Grant

- GENESEEQ grants LICENSEE a non-exclusive license, solely for the performance of the Purpose, to:
 - Download, execute, and display the Data and Code.
- This license is granted to LICENSEE alone and is not transferable, assignable, or sublicensable.
- LICENSEE may not create derivative works of the Data and Code without prior written consent from

GENESEEQ.

4. Restrictions

- Nothing in this Agreement grants LICENSEE any rights to:
 - Use the Data and Code for profit-making or commercial research.
 - Use any copyright, patent rights, or other intellectual property owned or controlled by GENESEEQ or its collaborators other than those rights explicitly granted herein.
- GENESEEQ, and any collaborators, are under no obligation to:
 - Provide updates or bug fixes to the Data and Code.
 - Provide information to LICENSEE not included in the Data and Code.

5. Disclaimer of Warranties

- LICENSEE understands that the Data and Code provided are experimental in nature.
- **GENESEEQ MAKES NO REPRESENTATIONS AND EXTENDS NO WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED.**
- **THERE ARE NO EXPRESS OR IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, OR THAT THE USE OF THE DATA AND CODE WILL NOT INFRINGE ANY PATENT, COPYRIGHT, TRADEMARK, OR OTHER RIGHTS OF THIRD PARTIES.**

6. Limitation of Liability

- In no event shall GENESEEQ, its affiliates, or their current and former directors, officers, employees, faculty, affiliated investigators, students, agents, and their respective successors, heirs, and assigns be liable for incidental or consequential damages of any kind, including, without limitation, economic damages or injury to property and lost profits, arising from or in connection with this Agreement or with the use of the Data and Code.

7. Indemnification

- LICENSEE agrees to hold GENESEEQ, its affiliates, and their current and former directors, officers, employees, faculty, affiliated investigators, students, agents, and their respective successors, heirs, and assigns harmless from any loss, claim, damage, or liability of any kind that may arise from or in connection with this Agreement or with the use of the Data and Code.

8. Compliance with Laws

- LICENSEE represents and warrants that they are not on any restricted party list.
- LICENSEE shall comply with all applicable laws and regulations controlling the export of commodities and technical data, including without limitation all Export Administration Regulations and any relevant international laws, including but not limited to the "Personal Information Protection Law of the People's Republic of China", "Regulations of the People's Republic of China on Administration of Human Genetic Resources", "Export Control Law of the People's Republic of China", "Copyright Law of the People's Republic of China", "Trademark Law of the People's Republic of China", "Civil Code of the People's Republic of China".
- LICENSEE bears sole responsibility for any violation of such laws and regulations. The LICENSEE shall take reasonable technical and organizational measures to ensure the security of the data, preventing unauthorized access, disclosure, or alteration. If the LICENSEE causes a data breach or violates the law through unauthorized use of the data, leading to other damages, the LICENSEE shall bear full legal responsibility and compensate GENESEEQ and its cooperating institutions for all losses suffered as a result, including but not limited to direct losses, indirect losses, and reasonable expenses.

- GENESEEQ may terminate this Agreement if LICENSEE breaches this Agreement; termination will be effective on the date the notice of termination is sent.
- Upon termination, LICENSEE shall provide GENESEEQ with written assurance that the original and all copies of the Data and Code have been destroyed, except that, upon prior written authorization from GENESEEQ, LICENSEE may retain a copy for archive purposes.
- Sections 2, 4, 5, 6, 7, and 9 will survive termination.

10. Ownership

- The Data and Code provided under this Agreement remain the property of GENESEEQ and any collaborating institutions.

11. No Use of Names

- Nothing in this Agreement confers any right to use in advertising, publicity, or other promotional activities any name, trade name, trademark, or other designation of GENESEEQ or its collaborators.
- Unless required by law, the use by LICENSEE of the name " Nanjing Geneseeq Technology, Inc. " or any adaptation thereof, or of any of its directors, officers, employees, faculty, students, agents, or affiliated investigators, is prohibited without prior written consent from GENESEEQ.

12. Governing Law

- This Agreement shall be construed, governed, interpreted, and applied in accordance with the internal laws, including but not limited to "Personal Information Protection Law of the People's Republic of China" and "Regulations of the People's Republic of China on Administration of Human Genetic Resources", without regard to conflict of laws principles.

13. Entire Agreement

- This Agreement constitutes the entire agreement between the parties regarding its subject matter and supersedes any prior oral or written communications or understandings between the parties related to its subject matter.
- No modification, amendment, or waiver may be made to the terms of this Agreement without the written consent of both parties.
